



## LIMITED WARRANTY

*You must register your product within 30 days of purchase to activate warranty coverage.*

**What Does This Warranty Cover?** This warranty covers defects or malfunctions in your new Tournament Saver Pro product.

**How Long Does The Coverage Last?** This warranty lasts for one (1) year after the date you purchased the Tournament Saver Pro product. This warranty is only extended to the first consumer who purchased the product; coverage terminates if you sell or otherwise transfer the product, whether separately or together with a boat into which the product has been installed. The coverage period for any applicable implied warranties is also limited to this same time period. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

**What Will Tournament Saver Pro Do?** Tournament Saver Pro LLC will, at our option and without charge to you, repair or replace any Tournament Saver Pro product that has a problem covered by this warranty, or refund the purchase price you paid for the product. You are responsible for uninstalling and reinstalling the product and for shipping charges to our service facility. We will pay the shipping charges to return the product to you if your address is within the United States and if there was a problem with the product covered by this warranty; otherwise, we will ship the product to you freight collect.

**What Does This Warranty Not Cover?** Any problems caused by abuse or misuse, or by improper installation, or by shipping damage, are not covered. In addition, this warranty does not cover any product that has an altered or missing serial number, or that was not registered with us within 30 days of purchase (see *How Do You Get Service?* below). This warranty does not cover any problem caused by the product being incorrectly serviced by a third party.

Consequential and incidental damages are not recoverable under this warranty. In no event will we be liable for any incidental, special, indirect, or consequential damages, whether resulting from the use, misuse, or inability to use the product, from defects in the product, or otherwise. In addition, our liability shall not exceed the amount you paid for the Tournament Saver Pro product that is the subject of a claim. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

**How Does State Law Apply?** This warranty gives you specific legal rights, and you may also have other rights

which vary from state to state.

**How Do You Get Service?** In order to be eligible for service under this warranty you **MUST** complete and return the warranty registration card found in the product box within 30 days of purchasing the product, along with your original purchase receipt with the Tournament Saver Pro product circled. (You should keep a copy of your receipt.)

If something goes wrong with your Tournament Saver Pro product, contact us at [service@tournamentsaverpro.com](mailto:service@tournamentsaverpro.com) to request a Return Material Authorization (RMA) number. If your product is under warranty, we will provide you an RMA number, which will be valid for 30 days. Then you will send your product, postage paid, with a brief written description of the problem to:

You are responsible for uninstalling the product (if it was already installed), for packaging it appropriately, and for insuring it (if you wish) against damage or loss while in shipment. Your RMA number must be on the outside of your shipping box or we will not accept the shipment at our service facility. Upon receipt of your product, we will inspect it. If there is a problem covered by this warranty, we will at our option (1) repair and return the product to you, (2) send you a replacement product that is either new or refurbished by us to like-new condition, or (3) refund to you the purchase price you paid for the product. **SUCH REMEDY SHALL BE THE CUSTOMER'S SOLE AND EXCLUSIVE REMEDY FOR ANY BREACH OF EXPRESS OR IMPLIED WARRANTIES.**

**Other Important Provisions.** To the maximum extent permitted by applicable law, this warranty and any disputes arising out of or in connection with this warranty shall be governed by United States federal law (to the extent applicable), and the laws of the State of Texas, USA, excluding conflicts of law principles and excluding the Convention for the International Sale of Goods; and the courts located in the State of Texas, USA shall have exclusive jurisdiction over any such disputes. If any provision of this warranty is unlawful, void or unenforceable, that provision shall be deemed severable and shall not affect any remaining provisions. In case of any inconsistency between the English version and any translation of this warranty, the English version shall prevail.
